Here is your chance to meet one of our enigmatic and engaging Animal Ambassadors one on one!

On this stellar Adventure, you will get up close and observe an animal training or play session. You will also learn all about the animal you are meeting from their favorite foods to how we work with them to better engage our guests and visitors and promote leadership conservation.

You will meet the animal care specialist in front of the White Oaks ITW Room near Wild Encounters. They will take you behind the scenes for your private meet and greet. There are many amazing ambassadors, and our care staff will go above and beyond to ensure you get to meet one of these wonderful animals. We cannot guarantee any specific animals and cannot take requests unfortunately.

At the end of the Adventure, you will bid the ambassador farewell. The care staff will answer any additional questions you have as they guide you back to the public area of the zoo.

Being an animal care specialist takes careful preparation. Here are some things you need to know so that you can be prepared to work side by side with the animal care specialist.

Communication between you and the host care staff is crucial. You must be able to read, speak, and understand English without the use of an interpreter. If you are unable to participate in the program without an interpreter, please call (708) 688-8338.

You must be attentive. Although our animals regularly work with their human caregivers, they are still wild animals, and their behavior is unpredictable. It is important that you pay close attention to the guidance and instructions of the animal care specialist you are spending the morning with. Never enter any animal area without direction from the care staff. Always wait for instructions and authorization from the staff before approaching any of the animals while participating in observation, care and enrichment, and feeding sessions. Participants must be able to maneuver within the behind-the-scenes habitat. Participants must wear a mask and wash their hands before the Adventure begins for the protection of the animals.

All participants are required to complete a signed liability waiver (page 4).

Frequently Asked Questions

Who can register for Otter Adventure?

- **Age**
Participants must be at least 8 years old. A parent or adult guardian must accompany participants under the age of 17. Please ensure you are putting the correct birthdate for each participant. Children under the age of 8 cannot participate in this Adventure. If a participant is not at least 8 years old, they may be refused participation and forfeit their registration fee.
- **Maximum Group Size**
Each Adventure is limited to 2 Participants.
- **Cost**
The cost for the Adventure is \$150.00 for one or two participants. It is the same cost, so you might as well bring a friend!

Can I take pictures during the program?

To keep the animals comfortable, pictures can be taken without flash. The care team will advise you as to when you can take your photos, and at the end of your Adventure, you may be able to take a selfie with the animal that you meet!

Where do we meet?

An animal care specialist will meet you in front of the White Oaks-ITW Room in Wild Encounters (see map below) at your session time of 10:45 a.m. or 1:45 p.m. Please wait in this area until an animal care specialist meets with you, do not wander away. Your Adventure will start promptly at your registered session time of 11:00 a.m. or 2:00 p.m. and cannot be extended if you are late.

You must be on Time.

Since you will be participating with a scheduled public feeding this Adventure must start on time. If you are late, the adventure will proceed without you. Participants that do not show up for their registered session or choose to leave early will not be granted a refund. Refunds are only available 14 calendar days before the program date and there will be a non-refundable 25% deposit for each program.

Please be aware that though it is rare, Backstage Adventures can be cancelled by Brookfield Zoo at any time due to animal welfare, dangerous weather, or staff needs. If your program is cancelled, you will be contacted with as much notice as possible to schedule another date for your adventure.

Safety Precautions.

You will be required to wash your hands and for the protection of the animals. Any refusal will mean your Adventure cannot proceed.

Ambassador Adventure Program Participant Waiver

I understand that I will be entering animal enclosures as part of the Ambassador Adventure (the "Program"). I UNDERSTAND THAT THE PROGRAM IS INHERENTLY DANGEROUS, AND I HEREBY WAIVE ANY AND ALL CLAIMS AGAINST THE CHICAGO ZOOLOGICAL SOCIETY, THE BROOKFIELD ZOO AND THEIR RESPECTIVE EMPLOYEES, OFFICERS AND TRUSTEES, RELATED TO OR ARISING FROM THE PROGRAM.

I consent to the use of my likeness in photographic, digital or electronic media by the Chicago Zoological Society in connection with the Program.

I attest that I meet the following requirements for the Program:

- I am at least 8 years of age.
- I understand that if a participant appears to be far under the age of 8, they will not be allowed to participate in this adventure including forfeit of registration fees.
- I possess the ability to read, speak and understand English without the use of an interpreter.
- I understand that I must wear a mask (one will be provided if you do not have one) and will wash my hands before interacting on this Adventure.
- I understand that if I am 17 years old or younger, I must have a parent or guardian report to the Program with me for an introduction and sign my liability waiver.
- I will not enter an animal area without direction from the Animal Care staff and I will wait for instructions and authorization from the Animal Care staff before attempting to touch the animals.
- If I haven't done so prior to my arrival, I will remove all jewelry (smooth wedding bands excepted) prior to going to the exhibit area. Prescription lenses worn for vision correction are acceptable.
- I understand that if I am under the influence of alcoholic beverages or any type of controlled substance, I will forfeit my right to participate in the Ambassador Adventure.
- I attest that I am in good general health and physical condition, suitable for Program participation.

I understand that the Chicago Zoological Society reserves the right to cancel the Program at any time where the best interest of the animals is concerned. I also understand that it is the animal's choice to participate in the program. I understand that I will be removed from the Program for failure to comply with the established rules and guidelines as set forth here, as established by the Chicago Zoological Society and as communicated by the Animal Care staff members.
