

The Chicago Board of Trade (CBOT) Endangered Species Fund (CBOT ESF) was founded in 1988 by Brookfield Zoo Chicago (BZC) Trustee Jerry Manne and his colleagues at the Chicago Board of Trade. Since that date, the CBOT Fund has supported projects around the globe focused on protecting species threatened with extinction. The CBOT Fund is administered by Brookfield Zoo Chicago in collaboration with an Advisory Committee.

Purpose

The CBOT ESF provides funding, such as strategic seed grants, for conservation related projects in the range of \$1,500 to \$7,000. Each year, approximately \$100,000 in grant funds are awarded. Funding is directed to key research and remediation projects affecting endangered wildlife and habitats worldwide. This includes projects that will quantitatively assess population and environmental status with indications for best conservation strategy and projects that will help achieve sustainable relations between local people and the species of concern.

Application Process

Applications are due August 31. Proposals that are focused around simple, fundamentally sound projects with measurable outcomes that can be reached receive higher priority.

Proposals may be endorsed by an IUCN Species Survival Committee or other major, internationally known conservation organization, the AZA/WAZA, or other major zoo organization. Proposals related to species, ecosystems, or regions in which BZC has a vested conservation interest are given priority.

For any individuals/organizations who are not U.S. citizens/entities, the Zoo checks the most recent OFAC Control List of Specifically Designated and Blocked Persons as well as the Consolidated List established and maintained by the 1267 Committee.

Examples of recent grants include:

- Evaluating the role of vampire bats and turkey vultures in the transmission of disease to endangered Humboldt penguins and pinnipeds at Punta San Juan, Peru
- Sunflowers to stop human/elephant conflict: an evaluation of the palatability and economic viability of an alternative crop
- Investigation of the effects of habitat fragmentation on population dynamics to conserve threatened Colobus angolensis palliatus in Kenya
- Using a participative model for the conservation of coral reefs on the Pacific coast of Mexico

Awards

The application process is competitive, with approximately 150 applications received each year for 20 to 30 annual grants.

An Internal Review Committee presents a qualified slate of applications to the Advisory Committee for consideration.

Awardees will be notified by March 1. Funds can be expected mid-April. Final reports are due 1 year after the receipt of the funds along with a final accounting of the grant fund expended. If reporting is not received, funds will be withheld for future projects.

Recipients will recognize the award by placing the verbiage "Supported by the Chicago Board of Trade Endangered Species Fund Grant administered by Brookfield Zoo Chicago" and/or using the Brookfield Zoo Chicago-provided grant program logo amongst a list of additional supporters on the grant recipient or organization's websites, publications, presentations, and or tangible products produced by the Award.

Requested Materials

1. Project Overview Video

• A concise, one-minute video summarizing your project.

2. Project Photos

- A minimum of 3–4 high-quality images that visually convey the essence and story of your project.
- Include proper credit attributions for all images submitted.

3. Executive Summary

• A written overview of the project designed for promotional use.

4. Formal References

• The formal names of the organization and project(s) as they should be referenced in promotional materials.

5. Logos (if available)

Provide your organization and/or project logo(s) for marketing use.

6. Social Media Information (if available)

 Relevant social media handles/accounts for tagging purposes on Facebook, Instagram, and LinkedIn.

7. Media/Marketing Contact (if available)

• Provide a direct contact for media and marketing coordination, reviews, and approvals, including name, title, email and phone number.

Technical Requirements (not required until awarded)

For Videos:

Length: Maximum 1 minute

• Resolution: High resolution (1280x720 pixels or above)

• Format: .mp4 or .mov

• Subtitles: Include English subtitles if narration is used.

For Photos:

• File Size: Minimum 2 MB

• Resolution: 300 ppi (pixels per inch)

• Format: JPEG

For Logos:

• Ensure submitted logos are in a high-resolution format suitable for digital and print use.

Executive Summary Guidelines:

- Word Count: Between 500 and 1,000 words.
- **Tone:** Avoid political inferences or discussions of policies that may be perceived as partisan.
- **Content:** Highlight all relevant partners and collaborators involved in the project. Clearly articulate the anticipated impact on wildlife conservation, science, and research.
